5. Adroddia Misol y Cyngorydd Sir - County Councillor's monthly report

Requested review of the speed limit and signage for a right turn on the junction to Plas Cwmcynfelin, and due to low incidents on the trunk road in that section, it does not warrant a review or need for signage

Clerc R.Evans requested a Grit box for Cllr.G.Lewis for the position by Noddfa and Bryncastell due to the severe conditions and danger to residents of the area and the Ddol during the severe weather. One was also requested for Dole and a replacement for the 3rd one on South Rd, Clarach. Click response 824067 is that no new bins will be considered during winter, but a review will be conducted during spring/summer, and once they have procured further bins, they will seek placements if they meet criteria.

6. Cynllunio- Planning

Concerns have been raised about the potential development of 150 houses being built on Cain Fallen. No application has come through, and Cllr.G.Lewis has also enquired, and there has been no submission through channels. It was noted that the framework would not hold that amount of housing and would unlikely be approved if submitted.
