New De-Fib and box for Llangorwen placement in motion once other de-fib removed from Hall.

G.L.Jones, parts, and fixings for Bryncastell replacement and safety updates of equipment have been completed. H&S for Bryncastell Park moving forward arranging the required inspections of the park & equipment. We are agreed that up to £550 inc vat would be an agreed price with provider.

Tregerddan Park due to H&S will remain closed - continue looking into how we will dispose of the old equipment and review the Dogs situation up there due to complaints of Dog mess. A sign to be placed up on the barrier.

Training for the community council to continue looking at dates they could undertake. The importance and emphasis of these training sessions were again re-iterated by the Clerc for a compliant community council and positive movement has been seen in attending these.

We discussed a need to increase our local councilors further and to engage and invite

those who wish to join to attend and see for themselves. They must show commitment and attend meetings before being considered for co-opted in.
